# PHOTO SUBMISSION GUIDELINES

## 1. RELEASE FORMS ARE CRITICAL!

**Absence of completed and signed forms will automatically eliminate your submission from consideration!**

Creative Age, publisher of *Inspire*, provides you with a Photo Information Form and various forms that must be filled out, signed and returned to Creative Age. Forms must be signed by all of the following people:

- “Salon Owner/Submitter Data Form”—To be completed by the person coordinating the photo shoot
- “Salon Owner Submission Agreement”—The salon owner who is submitting the photos
- “Stylist Release”—The hair-stylist(s), colorist(s), makeup artist(s), the set decorator, and others who participate in the photo session
- “Model Release”—The model(s) who appear in the photos
- “Ratification by Parent or Guardian of Minor”—If any of the models or stylists are under the age of 18, you will need the signature of a parent or guardian
- “Non-Exclusive Photography License”—The photographer(s) who took the photos
- “Photo Submission Form”—Lists the photographic images submitted for consideration, with appropriate credits)

## 2. PHOTOGRAPHY

A professional photographer will best represent your hard work and greatly increase your chances for inclusion in *Inspire*. A professional photographer knows about film, lighting and shadows. As noted above, the photographer *must* sign and return a “Non-Exclusive Photography License”.

## 3. LAYOUT

*INSPIRE* has a unique layout. When considering what to send, keep in mind that *INSPIRE* has sections for short, medium, long styles, men, and teens. We prefer to present work in collections or groups. For example, you should send in 3 or 4 models for each section. “Before” and “after” shots are great for showing dramatic changes. **Photos must show front, back and side views of your finished work.**

## 4. MODELS – Great Hair Deserves a Great Model

We publish work representing all types of people (children, adults, mature, male, female, and teens). We advise stretching your budget and hiring professional models. Professional models know how to pose for a photographer and are photogenic. Just because someone has a beautiful face doesn’t mean they photograph well. As noted above, photographers, models, hairstylists, and makeup artists as well as the salon owner *must* sign a “Stylist Release” forms.

## 5. CREDITS, CREDITS, CREDITS

Congratulations! You’ve made it through the selection process. However, we can’t credit the work without clear, concise credits. *Inspire* cannot be responsible for inaccurate or missing credits. Use the “Photo Submission Form” to give credit to the members of your team.

# PHOTO SHOOT GUIDELINES

## GENERAL GUIDELINES

### Keep the model's head the SAME SIZE!

Keep your camera at the same distance/location from the model throughout the shoot. An exception would be for more detail shots.

## LAYOUT

*INSPIRE* has a unique layout. When considering what to send, keep in mind that *INSPIRE* has sections for short, medium, long styles, men, and teens. We prefer to present work in collections or groups. For example, you should send in 3 or 4 models for each section. "Before" and "after" shots are great for showing dramatic changes. **Photos must show front, back and side views of your finished work.**

Photos: 10 x 12 inches  
"Before" Photos: 3 x 4 inches  
"After" Photos: 10 x 12 inches

## SAVE Photo Files as:

Portrait orientation  
CMYK (not RGB)  
Tiff or jpg format  
300 DPI

# SALON OWNER SUBMISSION AGREEMENT

For good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, he undersigned Salon Owner ("Owner") agrees as follows.

**1. Submission of Photographs.** Owner is hereby submitting to Creative Age Communications, its licensees, successors and assigns (collectively "Publisher"), the photographs described on the attached Photo Information Form, which is incorporated by reference herein (collectively "the Photographs"), for use by Publisher on the terms set forth below.

**2. Assurances.** Owner represents and warrants to Publisher as follows: (a) Owner, at Owner's sole cost and expense, has secured in writing all necessary rights, permissions and consents of third parties (such as, by way of example, photographers, models, hair-stylists, and makeup artists) who participated in the making of the Photographs and/or the other Licensed Materials in any way and has delivered such signed writings to Publisher; (b) Owner enjoys the right to grant the license set forth in this Submission Agreement without the further approval or consent of any other person; (c) Owner has not entered into any previous agreements, and will not purport to enter into any subsequent agreements, which would limit or hinder the rights of Publisher under this License; (d) photographers, models, hair-stylists, makeup artists, and others who participating in the making of the Photographs have been paid in full and no amounts are or will be owed by Publisher to the foregoing persons, the Owner and/or any third party by reason of any exploitation of the rights set forth above; (e) Owner will bear all costs and expenses that may be incurred in supplying Publisher with additional materials that Publisher may deem necessary and convenient; (f) Publisher may rely on this Submission Agreement in making use of the Photographs and the other Licensed Materials as set forth above; and (g) Owner shall indemnify, defend and hold harmless Publisher against any claims, lawsuits, damages, expenses, losses or liabilities arising from any breach of the foregoing or any other breach of this Submission Agreement by Owner.

**4. Rights of Publisher.** Publisher shall have the right but not the obligation to exploit the rights set forth above in its sole and absolute discretion. In the event of any inadvertent failure to afford credits by Publisher in connection with Publisher's use of the Photographs and/or other Licensed Materials, Publisher agrees to afford such credits at the first convenient opportunity.

**Copy this form for all participants (except photographer). Participants include: hair stylists, colorists, , makeup artists, set decorator, other.**

For good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the undersigned stylist ("Stylist") agrees as follows.

**1. Photographs.** Stylist hereby acknowledges and agrees that Stylist rendered services as a hair-stylist, makeup artist, set dresser, or other styling services in connection with the photographs described on the attached Photo Information Form, which is incorporated by reference herein (collectively "the Photographs").

**2.
